### Town Council

- ❖ We had members of the Rising Stars attend the meeting. Josh Yoder, Terry Pasierb, Josh Cowan, and Travis Harris. They would like to build a facility for youth sports. They are interested in the space behind the Lion's Club. The board said they would like to work together with them on the project. They are going to reach out to Beaver Township Trustee and we will possibly set up a meeting in the near future.

**Town Attorney (Becky Goddard)**

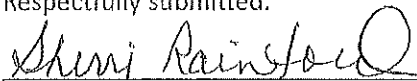
1. Becky has looked over and approved the easement request from Casey's. Nikki made a motion for Bob to sign the paperwork and Jason second. Motion passed 3-0.

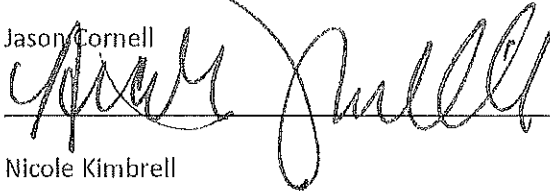
